'Agreement' means this form T11B Account Application including Terms and Conditions of Trade and including the Guarantee and Indemnity contained therein;

'Customer' means the person(s), company or business entity, their successors and assigns who has applied to Evolve Equipment Management for the supply of goods and/or services and includes any Guarantors of the Customer;

'Goods' means goods for sale, and/or services offered by Evolve Equipment Management

'GST' means the Goods and Services Tax levied on any supply made under this Agreement under A New Tax System (Goods and Services Tax) Act 1999 as amended from time to time or any tax resulting in an increase in the tax payable on the supply of goods by Evolve Equipment Management to the Customers;

Acknowledgements and Authority – Privacy Act 1988 (as amended)

The Customer:-

- Acknowledges Evolve Equipment Management may accept or reject such application in it's absolute discretion;
- Declares that the information provided above is true and correct and has been provided in an attempt to obtain a credit account.
- Agrees that this Agreement (as varied, if an, from time to time) form part of every transaction between Evolve Equipment Management and the Customer.
- And each of the officers of the Customer and any Guarantors/s gives consent to Evolve Equipment Management to:

Disclosing and obtaining personnel information to and/or from another credit provider or credit reporting agency including information relating to the commercial creditworthiness and personal creditworthiness of them;

Using any information obtained for the purposes of assessing this credit application, collecting payments due under this Agreement and notifying other credit providers of the commercial creditworthiness of them;

At any time you may gain access, upon request to the information we hold about you;

Evolve Equipment Management may disclose information about you where it has a duty to the public to disclose that information, and where it is required by law.

Acceptance

A credit account will be established upon completion of T11B Account Application form and verification of credit references. On approval of a credit account, credit may continue to be granted only if the account is maintained in accordance with the stated terms and conditions.

Upon successful application you will be notified in writing that your account has been established and advised of credit limit.

Evolve Equipment Management acknowledges that credit privileges, if granted, may be withdrawn at any time.

Payment Terms

The Customer agrees to pay the amount shown on any invoice or statement for goods or services supplied by Evolve Equipment Management plus any additional fees and charges applicable thereto either by the 27th day of the month immediately following the month of delivery or supply, or by the time stated for payment in delivery dockets, invoices or statements issued by Evolve Equipment Management, whichever is the earlier.

Payments of accounts may be made by Cash, Cheque, Credit Cards (MasterCard, Visa only) only and electronic funds transfer. A remittance advice must accompany all payments.

Retention of Title

Notwithstanding the risk in the goods shall have passed to the Customer, title and property in all goods shall remain with Evolve Equipment Management until full payment is made to Evolve Equipment Management for all moneys owing by the Customer on all accounts.

If the customer fails to make payment for the goods in accordance with this agreement, Evolve Equipment Management shall have the right to recover from the Customer all goods and for that purpose the servants or agents of Evolve Equipment Management may enter upon the Customers premises (or any premises under the control of the Customer or the Customer's agents if the goods are stored at other premises) in order to effect recovery and use any reasonable force to effect recovery without liability for trespass or any resulting damage. Evolve Equipment Management shall have the right to re-sell or otherwise dispose of the goods so recovered without reference to the Customer.

The Customer acknowledges that until the Customer's total indebted Evolve Equipment Management is discharged, the Customer shall hold the goods as bailee for Evolve Equipment Management.
